#### NOTES:

1. The Assessor determines the Estimated Market Value on January 2 of each year for taxes paid the following year
2. There must be a Local Board of Appeal and Equalization meeting between April 1 and May 31 for the following year
3. County Checks are received 3 times a year: June (From May 15 first half Property Taxes),  
November (From October 15 first second half of Property Taxes)  
January - Final Settlements from prior year
4. Gas Tax is paid out in February
5. State checks are paid in October and December
6. County Tax forfeited land paid in May
7. County in lieu of Taxes paid in August
