GUTHRIE TOWN BOARD MONTHLY MEETING MINUTES

The Guthrie Town Board met at the town hall at 8:00 p.m. on June 11, 2013 with Russ Nickerson, Roger Corson, Michael Schmidt, Kerri Wells, Randy Blake and Amanda Lofthus present. The minutes from the last months' meeting were recited and approved as read. The Treasurer gave the Monthly Financial report as \$45,391.88 in the General fund, which is inclusive of \$7,390.45 in the Cemetery fund. Russ motioned to approve the reports and Roger seconded the motion.

Roger obtained an estimate from Northland Tree Service to grind the three stumps for the township (two in the town hall yard and one in the cemetery yard) for \$170.00. Russ motioned to approve the motion, Michael seconded the motion.

Randy Blake is here to present a cemetery deed and payment from Bill Davis. Our Guthrie cemetery plot rates are currently \$125.00 for non-residents and \$25.00 for residents to purchase cemetery plots. Increasing the rates is thought to be on the agenda for the next annual meeting.

Russell made a motion to have Corson's Inc. replace a culvert on 255<sup>th</sup> and install a culvert on 444<sup>th</sup> and perform dirt work on 460<sup>th</sup>, 450<sup>th</sup>, 440<sup>th</sup> and 245<sup>th</sup>. Michael seconded the motion. This was the lowest of two bids received. The total amount for this work is \$4,460.00. The culvert costs are not inclusive in this bid. Gladen Construction's bid was also considered before this motion was made.

Michael will check with Bellefy Brushing for brushing and mowing prices to compare to Ingalls and Erickson and Hines Brushing costs.

Russell, Roger and Michael will plan to attend the Local Board of Equalization course on September 11, 2013 at the Park Rapids Courthouse from 9-12:00 noon.

Russ has installed the spring pony in the town hall yard. He also installed a "Watch for Children" sign near the Dahl residence on 420<sup>th</sup> and 255<sup>th</sup>. Roger motioned that if Troy Bouchert and Leah Rogers of Rocky Meadow Farms on 450<sup>th</sup> Street purchase the "Horse Crossing" signs they would like to be replaced, the township would install both of them at no cost. The signs were stolen within this last year that they were installed.

The next regular meeting will take place on July 9<sup>th</sup>, 2013 at 8:00 p.m. at the town hall. The summer short course will take place in Walker on June 26<sup>th</sup> at 8:00 a.m. for registration. Michael motioned to pay the bills, Roger seconded the motion. Russ motioned to adjourn, Michael seconded the motion.
